

ACKNOWLEDGEMENT OF RELEASE AND RESPONSIBILITY OF USE

In consideration for myself and members of my party or under my supervision being permitted to camp and participate in the activities at Oak Park Kampground, I and all persons listed below, agree to the following Waiver and Release:

“Pursuant to Minn. Stat. § 604.055, effective August 1, 2013, nothing in this agreement purports or intends to waive liability for damage, injuries, or death resulting from conduct that constitutes greater than ordinary negligence.”

I acknowledge that camping has many inherent and/or natural hazards and that there are risks that cannot be eliminated, particularly in a natural environment, with many obvious and hidden dangers. By signing this Acknowledgement, I agree that I am voluntarily camping with knowledge of the dangers involved and hereby agree to accept any and all risks of property damage, personal injury, disease or death caused by, but not limited to the following activities: Campfires, hiking, swimming, playground equipment, planned activities, animals (domestic and wild), restrooms, showers, pedal boat use, use of the shed, wagon rides and the possible reckless conduct of other people. These risks also include but are not limited to sunburn, heat exposure, poison ivy, animal and insect bites, weather-related incidences (flood, tornado, etc.), and water-related activities, including drowning in the pool or pond. I also understand that any equipment provided for my protection may be inadequate in preventing severe injury.

I hereby acknowledge that Oak Park Kampground is not responsible for any theft, loss or damage incurred during my stay.

I grant permission to Oak Park Kampground, its agents or employees, the irrevocable and unrestricted right to reproduce the photographs and/or video images taken of me or members of my family/party, for the purpose of publication, promotion, advertising or trade in any manner or in any medium. I hereby release Oak Park Kampground and its legal representatives to all claims or liability relating to said images and video. I waive my right to any compensation. Names will not be published.

My signature confirms that the rabies vaccination for any pet in my party is current and that I can produce, within 24 hours, a copy of the rabies vaccination certificate.

I understand that if the property is not left in the same condition that it was found, I will be billed at the rate of at least one-night stay or more depending on the condition of the campsite or rental. I further understand that I must report any damage to the property immediately upon arrival and that any damage not so reported will be presumed to have been caused by me. Damage shall include, but is not limited to, smoking in the rental, loss or damage to pillows, blankets, sheets, towels, pots, pans, dishes, kitchenware, candle burning damage, garbage which includes food thrown outside, inside or on the ground, bottles or cans of any type burnt in the fire ring, defacing of picnic tables or other property. Nonpayment of billed additional charges will be submitted to the sheriff's department and/or small claims court with all costs being assessed to the renter.

I have received, read and agree to abide by all campground rules, including but not limited to, those in the Guidelines for Happy Kamping, Pet Owner Courtesies and Social Distancing Guidelines.
